Dog Pond Border Collies (DPBC)

Governing Law and Jurisdiction: This Agreement shall be governed by and construed in accordance with the laws of the State of **Arizona**. The parties agree that any legal action, suit, or proceeding arising out of or relating to this Agreement shall be instituted exclusively in the federal or state courts located in **Yavapai County, Arizona**. Both parties waive any objection to the laying of venue in these courts.

California buyers, we will submit the health certificate to the CA Dept. of Food & Agriculture via [their portal] within 10 days.

1. Will provide registration papers for the puppy from AKC. You will be responsible for registering your puppy on the AKC website.
2. Will provide the medical record for your puppy to present to your veterinarian. DPBC has a veterinary exam within 3 days of the puppy's birth. We do not have the dew claws removed any longer as this can cause arthritis in adult dogs. The pups are re-evaluated at 6 weeks and given their first vaccinations and again at 9 weeks for their second set of vaccinations prior to going to their new home.
3. Will provide the genetic testing results showing that both dam and sire are clear of known Border Collie genetic ailments.
4. Will provide information on Puppy Culture- some helpful tips for when you take your new puppy home, a familiar blanket and our commitment to help you to help your dog to be a great companion! We will always be here for you to support you!

As the buyer, you are responsible for:

1. Make all necessary appointments for your new puppy with your veterinarian. DO not expose your puppy to dog parks, stores, dog-friendly public places, or allow your new puppy to be around unvaccinated animals until all necessary vaccinations have been completed. Parvo is a deadly virus that is prevalent in Arizona and affects animals more often in the spring and fall.
2. Provide appropriate care, feeding, housing, and veterinary care for your puppy now and for the lifetime of your new companion.
3. Agree that the puppy/ dog shall not be given away, or turned over to a rescue organization, shelter, or humane society. With written consent and approval of the breeder under extenuating circumstances (for example, you are unable to care for the dog for health or financial circumstances) your dog may be able to be placed in a different approved home. This puppy must never be used for medical, veterinary, or scientific research. If the Buyer is unable to keep

the dog, Breeder asks Buyer to return the puppy/dog to Breeder. The Breeder wishes all their puppies to have happy, healthy, forever homes and will take our puppies back for any reason.

4. Agree that this dog will not be used for breeding without the consideration of the breeder, appropriate health testing and providing that the dog will enhance the breed.
5. Agree that information regarding any titles the dog receives or achievements will be shared with the breeder/ kennel.

Recap/ Terms of sale:

The breeder guarantees that your new puppy is healthy at the time that it leaves the kennel, if your puppy falls ill within 48 hours and a veterinary exam determines that the puppy left the breeder with an ailment, the breeder will take the pup back and refund buyer minus the non-refundable deposit. If you choose to wait for a future litter your deposit may be applied to a different puppy.

Once the puppy leaves the breeder, it becomes your responsibility to continue with all recommended vaccinations and care to be determined by your veterinarian.

These are not shelter/ pound dogs. By signing below, you agree that if there ever comes a time with you cannot care for your animal, he/she will be returned to us without refund. If you can find a suitable home, you will allow us to vet said home and approve any new placement of our dogs.
